

## **IPMA** Program

Under the *Infrastructure Investment and Jobs Act of 2021*, nearly \$3.4 billion in federal formula funding will be allocated to the District of Columbia over five years for local infrastructure projects

#### Key DDOT Program Priorities Funded!

Substantial Federal Investment District's approved budget for DDOT in FY 2024 includes a \$201 million operating budget and a \$694m capital budget

#### The FY 2024 – FY 2029 Capital Improvements Plan (CIP)

- \$590.3m for bridge rehabilitation and replacement, including \$220.0 million for replacement of the H Street Bridge; \$211.1 million for reconstruction of the Benning Road Bridges; and \$151.3 million to rehabilitate the Theodore Roosevelt Memorial Bridge
- \$568.4m for local streets and alleys
- \$257.2m to improve safety and mobility, including \$90.9 million to install traffic safety infrastructure around schools
- \$236.5m for new or rehabilitated trail segments, including \$52.0 million for the Long Bridge pedestrian and bicycle connection; \$45.9 million for the Shepherd Branch Trail; \$36.5 million for the Anacostia River Trail; \$36.5 million for the Metropolitan Branch Trail; and \$25.4 million for the Suitland Parkway Trail
- **\$199.8m** for streetscapes projects
- \$87.8m for utilities, including \$57.8 million for placing select power feeders underground



### **Competitive Grant Funding**

- Twenty competitive grant applications submitted by DDOT over 2 years
- Six grants awarded to DDOT, five applications still pending a decision
- \$127M in project funding





#### **BRIDGE SIGNIFICANCE**

The bridge carries Interstate 66 between Arlington, VA and Washington DC across the Potomac and Little River

56 years in service (opened in 1964) 32.6 million vehicles per year (\$4,764 vehicles per day) 34,764 vehicles per day)

Traffic includes commuters as well as tourists traveling to the area attractions and entertainment in the District



If repairs are not completed, there is further risk to incur longer term traffic impacts or eventual closure of the bridge


### Rehabilitation of I-395 Northbound over the Potomac River




### South Capitol Street Trail

- <u>WHAT</u> Improves bicycle and pedestrian access along South Capitol Street/Overlook Avenue. The limits of the project extend for about 3.8 miles from the Firth Sterling Street/South Capitol Street intersection, southward along South Capitol Street/Overlook Avenue to Laboratory Road, and eastward under the I-295 overpass to Shepherds Parkway



Feasibility Study of I-295/DC-295 Corridor Redesign of North Capitol Street






